## Modification & Termination

Nitra may at any time: (i) modify or discontinue any part of the Marketplace; or (ii) charge, modify or waive fees required to use the Marketplace. Nitra reserves the right to make changes to these Terms & Conditions at any time, and such changes will be effective immediately upon being posted on the Marketplace. # **User Transactions**

You agree that all agreements, notices, disclosures and other communications that Nitra provides to you in accordance with the prior sentence satisfy any legal requirement that such communications be in writing. Notice shall be deemed given (i) 24 hours after the notice is posted on the Marketplace or an electronic message is sent, unless the sending party is notified that the message did not reach the recipient, or (ii)

in the case of mailing, three days after the date of mailing. You agree that a printed version of these Terms & Conditions and/or any notice given in electronic form shall be admissible in judicial or administrative proceedings based upon or relating to these Terms & Conditions to the same extent and subject to the same conditions as other business documents and records originally generated and maintained in printed form.

## Arbitration Agreement

Please read this section carefully. Except as the Terms & Conditions otherwise provide, you waive your rights to try any claim in court before a judge or jury and to bring or participate in any class, collective, or other representative action.

# Agreement to Binding Arbitration

You and Nitra agree that in the event of any claim, dispute, or controversy (whether in contract, tort, statute, or otherwise) arising out of, relating to, or connected in any way with (1) the Marketplace or (2) the breach, enforcement, interpretation, application, or validity of these Terms & Conditions, such claim, dispute or controversy will be resolved exclusively by final and binding arbitration, except as otherwise set forth in these Terms & Conditions (the "Arbitration Agreement").

# Exceptions to Arbitration

Notwithstanding the foregoing, in lieu of arbitration: (1) either you or Nitra can bring an individual claim in small claims court in the United States of America consistent with any applicable jurisdictional and monetary limits that may apply, provided that it is brought and maintained as an individual claim; and (2) you agree that you or Nitra may bring suit in court to enjoin infringement or other misuse of intellectual property rights.

Jury Trial & Class Action Waiver

Except as the Terms & Conditions otherwise provide, you and Nitra acknowledge and agree that you are each waiving the right to a trial by jury. The parties further agree that any arbitration shall be conducted in their individual capacities and not as a class action or other representative action, and the parties expressly waive their right to file a class action or seek relief on a class basis. You and Nitra may not be plaintiffs or class members in any purported class, collective, or representative proceeding, and may each bring claims against the other only in your or its individual capacity. The arbitrator may award declaratory or injunctive relief only on an individual basis and only to the extent necessary to provide relief warranted by the individual claim.

If any court or arbitrator determines that any term in the immediately preceding paragraph is unenforceable for any reason as to any claim, then the Arbitration Agreement will be inapplicable to that claim, and that claim will instead proceed through litigation in court rather than by arbitration, but only after the conclusion of the arbitration of any claim or dispute that is subject to the Arbitration Agreement.

# Governing Law & Arbitration Rules

The Arbitration Agreement evidences a transaction in interstate commerce and thus the Federal Arbitration Act, 9 U.S.C. § 1 et seq. ("FAA"), will govern the interpretation and enforcement of this section. If the FAA is found not to apply to any issue that arises under this section or the enforcement of the Arbitration Agreement, then that issue shall be resolved under the laws of the State of New York.

The arbitration will be conducted under the then current and applicable rules of the American Arbitration Association ("AAA"). The AAA rules are available online at www.adr.org or by calling the AAA at 1-800-778-7879.

# Initiating Arbitration

If you intend to seek arbitration you must first send a written notice ("Notice"), by first class or certified mail to Nitra Marketplace, Attention: Legal Department, One World Trade Center, 285 Fulton Street, Suite 84A, New York, NY 10007. If Nitra intends to seek arbitration, Nitra will send a Notice to the current billing address on your account. The Notice must describe the nature and basis of the claim and the specific relief sought. If the parties cannot reach an agreement within 30 days from the receipt of the Notice, either party may initiate arbitration proceedings.

A form to initiate arbitration proceedings is available on the AAA site at www.adr.org. In addition to filing this form with the AAA, the party initiating the arbitration must mail a copy of the completed form to the opposing party. You may send such copy to Nitra at Nitra Marketplace, Attention: Legal Department, One World Trade Center, 285 Fulton Street, Suite 84A, New York, NY 10007, and Nitra will send such copy to the current billing address on your account or to your attorney, if you have retained one. Location & Procedure

If your claim is for \$10,000 (US Dollars) or less, you may choose to have arbitration conducted solely on the basis of documents submitted to the arbitrator, via a telephone hearing, by an in-person hearing in the county of your residence, or as otherwise mutually agreed to by the parties. If your claim exceeds \$10,000 (US Dollars), the location of the arbitration and the parties' right to a hearing will be determined in accordance with the rules of the AAA.

## Arbitrator's Decision

The arbitrator's award shall be written, and binding on the parties and may be entered as a judgment in any court of competent jurisdiction.

Choice of Law, Forum Selection, & Jury Waiver

Except as set forth in the Arbitration Agreement section above, all matters relating to your access to or use of the site and all matters arising out of or related to these Terms & Conditions, will be governed by

the applicable laws of the United States of America and the laws of the State of Delaware, without regard to Delaware's choice of law principles. Unless you and Nitra agree otherwise, in the event that it is determined or these Terms & Conditions provide that a claim should not proceed through arbitration, you agree that any claim or dispute (with the exception of a claim or dispute appropriately lodged in any small claims court in the United States of America) shall be resolved in the United States District Court for the South District of New York, and you submit to the personal jurisdiction of that court. If subject matter jurisdiction (including diversity jurisdiction) does not exist in the United States District Court for the Southern District of New York for any such claim, then the exclusive forum and venue for any such action shall be the courts of the State of New York located in New York County, and you submit to the personal jurisdiction of that court. As to any proceeding in court, you and Nitra both waive your right to a jury trial, unless such waiver is unenforceable.

The choice-of-law and forum-selection provisions in this section do not apply to the Arbitration Agreement or to any arbitrable disputes as provided by the Arbitration Agreement section. Instead, as provided in the Arbitration Agreement section, the FAA shall apply to any such disputes.

# Entire Agreement; Waiver; Severability; Assignment; Force Majeure

These Terms & Conditions, including policies and information linked from or incorporated herein or otherwise found on the Marketplace, constitute the entire agreement between you and Nitra with respect to the Marketplace and supersede all prior or contemporaneous communications, agreements, and proposals with respect to the Marketplace. No provision of these Terms & Conditions shall be waived except pursuant to a writing executed by the party against whom the waiver is sought. No failure to exercise, partial exercise of, or delay in exercising any right or remedy under these Terms & Conditions shall operate as a waiver or estoppel of any right, remedy, or condition. Except as provided in the Arbitration Agreement section, if any provision of these Terms & Conditions is held invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions will not be affected or impaired. You may not assign, transfer, or sublicense any of your rights or obligations under these Terms & Conditil any obligation due to causes beyond our control.

Identical products are those offered in the same quantities and qualities and bearing the same SKU.

Our Price Match Guarantee does not cover:

- Pricing only available to select groups of customers including Nitra Card accountholders, loyalty members or loyalty offers, discounts relating to non-warehouse membership, or paid loyalty programs.
- Any financing offers, bundle offers, items included in bundle offers, subscription services, free items, pricing errors, mail-in offers, coupon offers, items that are advertised as limited quantity, out of stock items, clearance items, open-box items, refurbished items, and pre-owned items.

# Process for Requesting Price Match

## 1. Find a qualifying product

Find a qualifying product that you want Nitra to price match. Make sure the product you would like to price match is an immediately available new product and is identical to the product on our Marketplace (it must be a matching brand with identical SKU).

## 2. Chat or call to request a price match

Connect with us via chat or by phone. Please be prepared to direct us to the website that is displaying the current lower price you would like to match, or to send us your GPO purchase order within the last month for GPO price matching. If we can validate the lower price with you, and all other criteria are met, we will honor that lower price. We may refuse a price match in our sole discretion for any suspected fraud or abuse.

## Out of Stock or Limited Quantities

Retailers may advertise a product in ads or on their website as having limited quantities in stock. If the item is out of stock or the retailer has advertised as limited quantities of an item, it is not eligible for price matching.

## Warehouse Clubs

We will match the prices of warehouse clubs as long as all price match criteria are met. If the warehouse club website price requires a membership identification or login to view, price match is available only if you can display such pricing to us via screen share or other real-time interaction.

## Concierge Purchasing

If you are a Nitra Card accountholder, our dedicated customer success team will help your business find the supplies you need if they are not available to be purchased through our Marketplace. Note that we cannot guarantee that we can find the product you're looking for, or the quantities or pricing you're looking for, but we will endeavor to do our best. We will let you know within one business day if we are able to locate the product(s); if so, we will direct you to the specific vendor so that you may complete the transaction directly on your Nitra Card. All purchases and any product warranties will run directly between you and the vendor.
